Betingelser og Vilkår for Reservation af Selskaber

Afbestilling: Hvis du har behov for at afbestille et selskabsarrangement, gælder følgende regler:

- Arrangementer mindre end 20 personer skal afbestilling ske skriftligt senest 7 dage før arrangementsdatoen.
- Arrangementer med 20-40 personer skal afbestilling ske skriftligt senest 14 dage før arrangementsdatoen.
- Arrangementer med mere end 40 personer eller ved booking af privatlokale skal afbestilling ske skriftligt senest 4 uger før arrangementsdatoen. Ved senere afbestilling vil I blive faktureret for den aftalte menu eller 50 % af den aftalte minimumspris.
- Arrangementer mere end 40 personer eller ved booking af privatlokale. Ved afbud senere end 7 dage før arrangementet eller ved udeblivelse faktureres den fulde minimumspris.

Afbudspolitik:

- Det endelige antal deltagere skal bekræftes senest 7 dage før reservationen.
- Der kan afmeldes op til 10 % af de bekræftede deltagere uden beregning indtil 48 timer før reservationen, medmindre der er aftalt et minimumsforbrug.
- Afmeldte kuverter på dagen faktureres fuldt ud – også ved sygdom.

Forplejning:

- Eventuelle allergier, diætønsker eller andre særlige behov bedes meddelt hurtigst muligt.
- Menuen tager udgangspunkt i den aktuelle sammensætning, og der tages forbehold for ændringer.

Betaling:

- Regningen afregnes samlet. Transaktioner kan blive pålagt gebyr i henhold til NETS' gældende takster.
- Ved betaling via faktura pålægges et administrationsgebyr på 300 kr. Oplysninger skal indeholde:
 - ✓ Navn
 - ✓ E-mail
 - ✓ Att.
 - ✓ Adresse
 - ✓ CVR-nummer
- Fakturabetaling skal aftales på forhånd. Faktura eftersendes ikke som kvittering, hvis betaling sker på dagen.

Depositum: (kun ved større selskaber)

- Ved bestilling betales et depositum på 15.000 kr.
- Depositum refunderes ved afbestilling senest 4 uger inden arrangementsdatoen.
- Depositummet bruges som en del af den samlede betaling for arrangementet.

Arrangementet er først endeligt bekræftet ved modtagelse af depositum.

Terms and Conditions for Booking Parties

Cancellation: If you need to cancel a party event, the following rules apply:

- Events with less than 20 people must be cancelled in writing no later than 7 days before the event date.
- Events with 20-40 people must be cancelled in writing no later than 14 days before the event date.
- Events with more than 40 people or when booking a private room, cancellation must be made in writing no later than 4 weeks before the event date. In case of later cancellation, you will be invoiced for the agreed menu or 50% of the agreed minimum price.
- Events more than 40 people or when booking a private room. In case of cancellation later than 7 days before the event or in case of no-show, the full minimum price will be invoiced.

Cancellation policy:

- The final number of participants must be confirmed no later than 7 days before booking.
- Up to 10% of confirmed participants can be unsubscribed free of charge up to 48 hours before booking.
- Cancelled covers on the day will be invoiced in full – even in case of illness.

Dietary:

- Any allergies, dietary wishes or other special needs should be communicated as soon as possible.
- The menu is based on the current composition and is subject to change.

Payment:

- The bill is settled together. Transactions may be subject to a fee in accordance with NETS' applicable rates.
- When paying by invoice, an administration fee of DKK 300 will be charged. Information must include:
 - ✓ Name
 - ✓ Email
 - ✓ At.
 - ✓ Address
 - ✓ CVR number
- Invoice payment must be agreed in advance. Invoices will not be sent as a receipt if payment is made on the day.

Depositum (only for larger groups):

- When booking, a deposit of DKK 15,000 is paid.
- The deposit will be refunded if cancelled no later than 4 weeks before the event date.
- The deposit is used as part of the total payment for the event.
- The arrangement is only finally confirmed upon receipt of the deposit.
